



The decision of Chairman in a meeting shall be conclusive and final and in case of a poll on any of the agenda of the meeting, the Trustee Cum Chairman shall have a second or casting vote.

It will be the duty of Trustee Cum Chairman to see the proper implementation of decision taken in the meeting.

#### POWER AND DUTIES OF BOARD OF TRUSTEE.

- a) Only the Board of Trustee shall power to appoint suspend, terminate any employee of the trust or any institution run by the trust and also to fix their remuneration, perquisite etc.
- b) Board of trustee shall appoint accountant to maintain the proper accounts of the trust and the institution run by the trust. The accountant shall be responsible depositing the cash collection in the bank/post office.
- c) The withdrawals from the bank can be made from bank by the joint signature of any two members of the Board of Trustee. However, in future, the Board of Trustee may changes the signature pattern/system for making withdrawals from bank.
- d) Board of trustee can appoint more trustees but the total number should not exceed 20 (Twenty).

### POWER AND DUTIES OF TRUSTEE CUM SECRETARY
